# **Policy Updates**

# **New Supreme Court Justice**

On August 7<sup>th</sup>, Elena Kagan was sworn in as the newest Justice on the Supreme Court. With the addition of Kagan, three women now sit on the Supreme Court for the first time in history. Kagan formerly served as both Solicitor General and Dean of Harvard Law School, the first woman to hold either of those positions. The vote to confirm Kagan was 63-37, with anti-choice Senator Ben Nelson the sole Democratic Senator to vote against her

## **Health Care Reform**

After a nearly year-long debate, Congress passed the Patient Protection and Affordable Care Act, the first major health care reform initiative in decades. During Congress' consideration of the bill there were numerous attempts to limit women's access to abortion care. The most extreme anti-choice effort was led by Representative Bart Stupak (D-MI). The proposed Stupak amendment would have essentially barred coverage of abortion by health insurance plans operating in the newly created exchanges. After the Senate defeated a version of the Stupak amendment, it passed another anti-choice provision authored by Senator Ben Nelson (D-NE). Unfortunately, the Nelson amendment was included in the law that President Obama signed. The amendment's primary restriction is a "two check" policy that requires a separate payment for premiums for abortion coverage.

This summer, as part of the Obama Administration's implementation of the new law, the Department of Health and Human Services Since issued regulations that would prohibit coverage of abortion care in the newly-created high risk pools, which are designed to serve individuals with pre-existing conditions. This restriction on abortion care was not required by the law itself and creates an additional burden to coverage for women who are often at the highest risk for abnormal pregnancies and fetal anomalies.

# Welcome to the newest CFC newsletter feature: The Resource Corner!

This section will feature new and immerging resources that are applicable for pro-choice NPs, CNMs, and PAs.

Please send resources you have created and would like to have included in this section to Emily Kane-Lee, CFC's Coordinator, at ekanelee@prochoice.org Values clarification is an essential part of training for health care providers. This is especially true for health care professionals who deal with controversial or emotionally charged topics such as abortion. In spite of our efforts at objectivity, we all hold personal values that can influence how we respond to patients, clients, and other individuals with whom we interact.

NAF offers a values clarification workshop, which is flexible, both in terms of timing and content. A typical workshop lasts 90 minutes to two hours and incorporates a number of different activities to encourage participants to think about and articulate their attitudes and opinions related to pregnancy options and abortion. Topics addressed include:

- articulating the reasons behind their views about various aspects of abortion;
- risk taking-behavior and its relationship to unintended pregnancy;
- examining comfort level with gestational age;
- examining comfort level with circumstances of each woman's abortion decision:
- individual cases—examining potential biases;
- pregnancy options decision making;
- personal assessment of professional obligations;
- the decision to provide abortion care—motivation and obstacles; &
- understanding perspectives on abortion-related state and federal laws.

### **Providing Abortion Care:**

A Professional Toolkit for Nurse-Midwives, Nurse Practitioners, and Physician Assistants

Launched last year as a joint project of AAP, ANSIRH, and NAF, this toolkit informs, supports, and catalyzes efforts to promote the provision of abortion by NPs, CNMs, and PAs.

The Toolkit includes essential information and statistics about:

- Abortion and access to abortion
- Professional regulation, competencies, and responsibilities

The Toolkit helps clinicians compile crucial evidence and documentation to support the integration of early abortion care by guiding clinicians in the development of a professional portfolio which documents:

- · Basic and abortion-specialty education, knowledge, and training
- The clinical and professional standards they use in providing safe care
